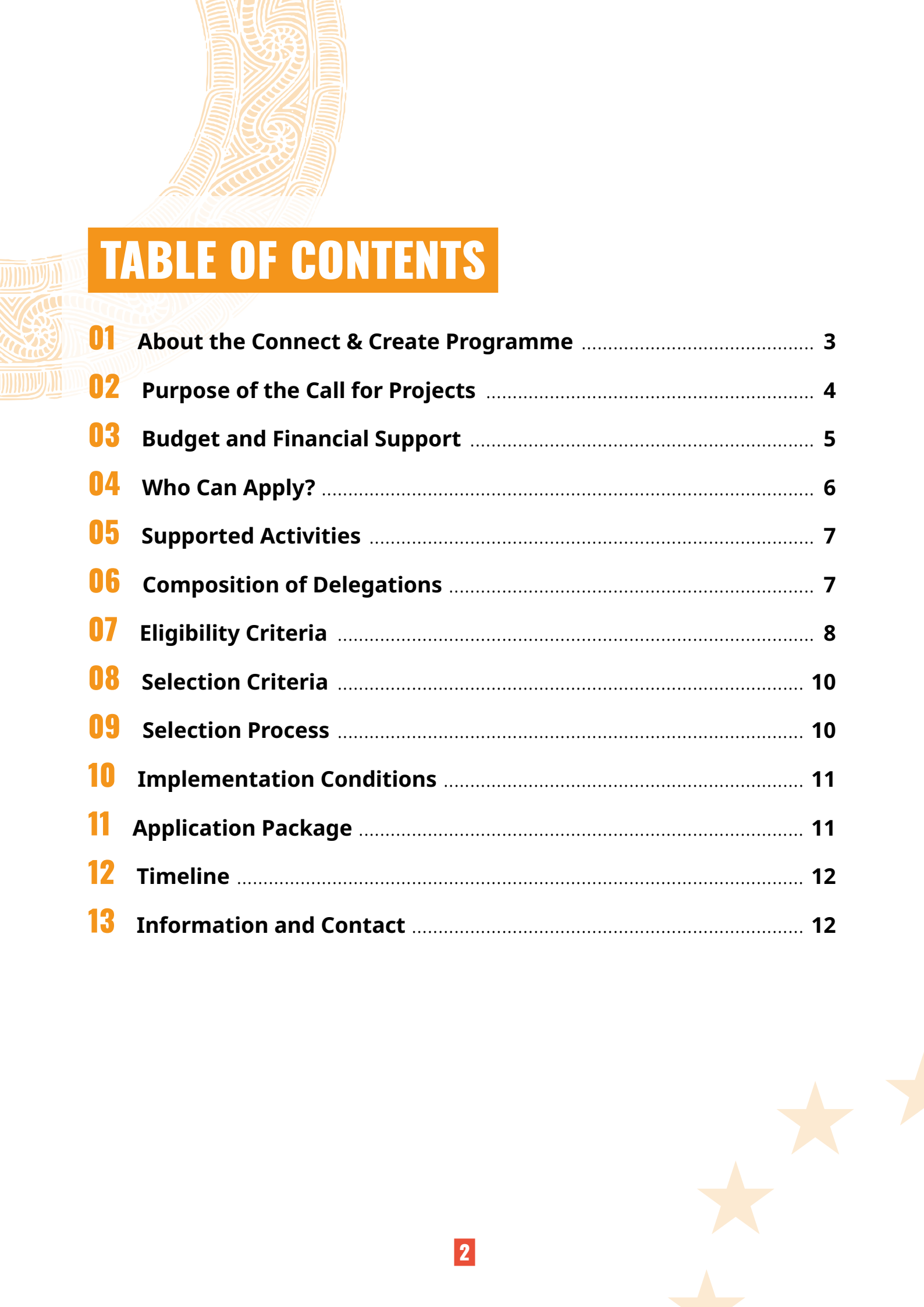

ABOUT THE CONNECT & CREATE PROGRAMME



Connect & Create - Africa-Europe Partnerships for Culture is a programme funded by the European Union. It aims to strengthen cultural ties between Sub-Saharan Africa and Europe through equitable, inclusive and sustainable cooperation.

The programme is implemented by a consortium composed of the Goethe-Institut and Expertise France, in collaboration with the Institut français.

The programme supports:

- artistic cooperation;
- the mobility of cultural professionals and artistic works;
- networking initiatives;
- mutual learning among African and European cultural stakeholders.

The Institut français and Expertise France play a key role in the fields of performing arts and music by leading mobility, international co-production and exchange initiatives for artists and cultural professionals.

PURPOSE OF THE CALL FOR PROJECTS

The Connect & Create #Professional Mobility call for projects supports organisations and international events hosting delegations of professionals from the performing arts and music sectors.

Its objectives are to promote:

- professional exchanges between Africa and Europe;
- sustainable collaborations;
- the development of international networks;
- the strengthening of cultural ecosystems.



Supported projects must offer professional programmes integrated into international events such as:

- festivals, trade fairs and professional markets;
- conventions, seminars and symposiums;
- workshops and professional meetings.

BUDGET AND FINANCIAL SUPPORT

OVERALL BUDGET

A maximum envelope of EUR 90,000 is available. Connect & Create reserves the right not to allocate the full amount of funding based on the evaluation of the projects received.

GRANT AMOUNT

Each selected project may receive funding ranging from:

- EUR 10,000 minimum;
- EUR 20,000 maximum.

ELIGIBLE EXPENSES

The following costs may be covered:

- international, national and local travel expenses for individuals traveling in economy class or equivalent;
- visa and insurance costs;
- per diem (covering accommodation, meals, and local transportation) ;
- translation costs.

CO-FINANCING RATE

The grant awarded may not exceed 70% of the project's total budget.

Applicants must demonstrate at least 30% co-financing, either in cash or through in-kind contributions.

PAYMENT TERMS

Funding will be disbursed in two instalments:

- 80% upon signature of the grant agreement;
- 20% upon completion of the project, following approval of the narrative and financial reports.

04 WHO CAN APPLY?

THE FOLLOWING ENTITIES ARE ELIGIBLE TO APPLY

- associations;
- foundations;
- cultural institutions;
- private companies;
- other professional cultural organisations.

APPLICANT ORGANISATIONS MUST

- be established in one of the 47 Sub-Saharan African countries or one of the 27 European Union Member States;
- have been legally registered for at least 2 years;
- be able to provide proof of legal registration;
- hold a bank account enabling international transfers;
- demonstrate significant experience in the performing arts or music sectors.

PLEASE NOTE: European organisations must demonstrate existing partnerships or established links with Sub-Saharan Africa.

SUPPORTED ACTIVITIES

Projects must propose programmes designed for cultural professionals.

Activities may include:

- opportunities to discover local and international artistic scenes;
- training activities;
- conferences and experience-sharing sessions;
- networking activities;
- B2B meetings.

COMPOSITION OF DELEGATIONS

Delegations must:

- include at least 8 cultural professionals aged 18 or over;
- reflect a strong degree of international diversity.

Diversity Requirements

- a minimum of 5 African and/or European nationalities for delegations of 8 to 10 professionals;
- a minimum of 8 African and/or European nationalities for delegations of more than 10 professionals.

ELIGIBLE PROFILES

Delegations may notably include:

- programmers/curators;
- producers;
- agents;
- event organisers;
- network coordinators;
- company representatives;
- festival representatives.

ELIGIBILITY CRITERIA

TYPES OF SUPPORTED MOBILITY

MOBILITY TO EUROPE

Support will be provided exclusively to African professionals.

MOBILITY TO SUB-SAHARAN AFRICA

Support may be provided to African and/or European professionals.

ELIGIBLE DISCIPLINES

The call is open to all disciplines within the performing arts and music sectors, including:

- theatre;
- dance;
- performance art;
- circus arts;
- street arts;
- puppetry;
- music.

08 SELECTION CRITERIA

PROJECTS WILL BE ASSESSED BASED ON:

- their relevance to the programme's objectives;
- prospects for cooperation and networking;
- long-term impact;
- the organisation's experience in hosting professional delegations;
- the quality of the proposed programme;
- geographical, linguistic and gender diversity within the delegation;
- the quality of the profiles involved.

PARTICULAR ATTENTION WILL BE GIVEN TO PROJECTS THAT:

- are characterized by their originality, their strong connection to their context, and the distinctive nature of their approach;
- foster long-term collaboration;
- support younger generations;
- showcase emerging artistic scenes;
- incorporate environmentally responsible practices;
- address inclusion and accessibility issues.

09 SELECTION PROCESS

THE SELECTION PROCESS WILL INVOLVE SEVERAL STAGES:

- verification of eligibility requirements;
- comprehensive assessment of applications by evaluators;
- review by a selection committee composed of representatives from Expertise France, the Institut français, the project team and independent experts.

Results will be communicated to applicants by email.

IMPLEMENTATION CONDITIONS

PROJECTS MUST:

- be implemented in Sub-Saharan Africa, in a European Union Member State, or across both regions;
- take place between February and December 2027.

APPLICATION PACKAGE

Applications must be submitted online through the IF Prog platform, which can be accessed via the [website of the Institut français](#).

MANDATORY DOCUMENTS

- application form;
- project presentation document (free format) ;
- provisional budget;
- implementation timeline (free format);
- logical framework;
- declaration of honour regarding exclusion criteria and the absence of conflicts of interest.

DOCUMENTS AVAILABLE FOR CONSULTATION

- the grant agreement template.

LANGUAGE OF THE APPLICATION

- applications must be submitted in either French or English.

ADDITIONAL ADMINISTRATIVE REQUIREMENTS

- The use of the templates provided under this call for projects is mandatory for all required documents. Any document submitted in another format may be considered non-compliant.
- Incomplete applications or applications that do not comply with the submission requirements outlined in the call will be deemed ineligible.
- Additional administrative and financial documents may be requested from selected organisations during the contracting phase.
